
Dear Neighbour,

We'd like to take this opportunity to introduce ourselves to our neighbours. John F Hunt LTD have been appointed by Freshwater as the main contractor to undertake the enabling and Demolition works for the Tenter House Project.

To keep you updated on the progress of the works and any upcoming activities we will be sending monthly/regular newsletters to immediate neighbours. These will also be available to download on the project website: https://tenterhouse.co.uk

We have installed our site welfare / temporary electrics and commenced soft strip activities in early March. We have now Commenced the Main works as of Wednesday 01st May: The Works are as of the with the below

- Install security fencing / hoarding and scaffolding around the site (see plan below) designed and constructed in line with the City of London Code of Construction Practice.
- Continuation of soft strip works.
- Commenced internal first floor window removal works to facilitate scaffold works.





We will be taking various steps to minimise the impact to neighbours, including:

- Working hours in line with City of London guidance: 8am 6pm Monday Friday.
- Reduced Impact Hours: 10.00 to 12.00 and 14.00 to 16.00.
- Unloading materials within the site area behind the hoardings.
- Ensuring public areas are kept clear and maintaining access for residents.
- Keeping deliveries to a minimum and using smaller vehicles whenever possible
- Entrance will have a designated Traffic Marshal to supervise, and ensure the areas are kept clean, safe, and secure.

 Dedicated on-site team, will be available during site hours and 24 hours in the event of a site emergency.
